3. NEW BUSINESS

a. Griff Salmon and Nancy Blum-Heintz presented Phase I of the Strategic Plan for Economic Development in Highlands County. Data from the public survey was reviewed and key takeaways were noted. Highlands County had an unprecedented number of responses, with almost 1,000 surveys submitted. VisionFirst identified one of the greatest challenges faced by Highlands County as the lack of sites available with existing infrastructure and the difficulty to quickly obtain information regarding the cost and time required to extend infrastructure. Another element that was discussed is the misalignment between perceptions of the public and government officials versus reality. 98% of those surveyed, wanted to see commercial or industrial growth in Highlands County to some degree, which contradicted the common belief that residents do not want to see growth. Additionally, individuals compare Highlands County to Polk County due to their close proximity, however Polk County should not be used as a comparison due to their differing economy. Polk County has approximately, 20 individuals serving their Economic Development Division, whereas, Highlands county has 2. VisionFirst Advisors recommend that Highland's County hires a third individual on the Economic Development team to act as a liaison between training and learning facilities and employers. Carol Howard requested literature, or samples, from other municipalities throughout the state as examples of how they have implemented similar strategic plans.
